### Springfield Secure Treatment Program

In 2002, the Massachusetts Department of Youth Services (DYS) requested that the Springfield Secure Treatment Program participate in a project being conducted by the Council of Juvenile Correctional Administrators (CJCA). This project focuses on ways of improving the care of adolescents in detention and correctional facilities.

What made the request unique was that we at the facility and RFK were the first and at the time, the only provider agency asked to take part from Massachusetts. At first we thought: is this going to resemble the ACA Certification project we participated in and how many copy machines were we going to destroy during the process?

We quickly learned that this was not really like the ACA project, as this project looked at service delivery areas within the program and provided ways to improve those areas through a Facility Improvement Plan

Brendan McWade and the staff at the Springfield Secure Treatment Program discovered that the data collection and analysis required by PbS is not as complicated as they anticipated it would be. Despite their initial anxieties about participating in the project, they realized that PbS is more than gathering data. It is a meaningful management tool that helps their facility identify issues and plan for improvement. After the October 2008 data collection, the Springfield Secure Treatment Program had mastered all the PbS definitional compliance and process competencies as well as performed better than the PbS field average in more that 85 percent of the critical outcome measures. This notable accomplishment demonstrates Brendan and his colleagues' commitment to continuous improvement of their facility and its programs.
